The Company hereby appoints the Medical Centre to provide basic medical care, first-aid facilities, medical treatment and services for its employees at concessional rates who are registered with the Centre for the same and it shall be provided from the present as also from the future Medical Care Centres that may be established by the Medical Centre.

2. DURATION
