THIS AGREEMENT is made at _____ this day of _____

or meaning thereof, be deemed to mean and include his heirs, executors,
administrators, legal representatives and assigns) of the **OTHER PART**;

WHEREAS:-

- (a) The Producer intends to produce a cinematographic film in

Film**").
- (b) The Composer is the Composer and Director known for
composing the musical works in feature films and for private
albums.

- (c) The Producer is hereby desirous of employing the services of the Composer for composing the musical works consisting of musical songs/works as per the prevailing practice of the film trade for the said Film and which employment is accepted by the Composer.
- (d) The parties are desirous of recording the terms and conditions of the aforesaid agreement as appearing hereinafter.

NOW THESE PRESENTS WITNESSETH AND IT IS HEREBY AGREED AND RECORDED BY AND BETWEEN THE PARTIES HERETO AS HEREUNDER:

1. RECITALS

The aforesaid recitals shall form an integral part of this Agreement.

2. SERVICES

- (a) The Producer hereby employs the Composer and engages his services for composing the musical works consisting of musical songs/works in respect of eight musical songs in _____ language as also promotional musical works for the same (hereinafter referred to as **“the said musical works”**) as more particularly set out in the **SCHEDULE** hereunder written on the terms and conditions recorded herein.
- (b) The services of the Composer shall consist of the followings:-
- (i) creating, composing, arranging, revising and adopting musical works, composition of lyrics and musical
