THIS AGREEMENT is made at _____

- (a) The Producer intends to produce a cinematographic film

- (b) The Singer is a professional Singer and vocal performer of live and
recorded music and is capable of performing for the purposes of
audio recording.

- (c) The said Film will feature several musical songs/works (hereinafter referred to as **“the said musical works”**) and are more particularly described in the **SCHEDULE** hereunder written.
- (d) The Producer is desirous of engaging the services of the Singer for the said musical works or part thereof and such employment has been accepted by the Singer.
- (e) The Parties hereto are desirous of recording the agreed terms and conditions in writing as appearing hereinafter.

NOW THESE PRESENTS WITNESSETH AND IT IS HEREBY AGREED AND RECORDED BY AND BETWEEN THE PARTIES HERETO AS HEREUNDER:

1. RECITALS

The aforesaid recitals shall form an integral part of this Agreement.

2. SERVICES

- (a) The Producer hereby employs the Singer and engages his services for singing and rendering vocal performance in and of the said musical works and for the purpose of incorporating such vocal performance in a sound recording as per the requirements of the Music Composer (**“the said Music Composer”**) and the Producer, for the said Film or otherwise, or independently for any use, commercial or otherwise. The engagement of the said Singer shall be on non-exclusive basis for the said Film. It shall be the sole discretion of the Producer
