THE PLAINTIFF ABOVENAMED STATES AND SUBMITS AS FOLLOWS:

1. The Plaintiff is the company incorporated under the Netherlands's Companies Act, having its registered office at the address mentioned in the cause title hereinabove. The Plaintiff is engaged in the
