

## ASSIGNMENT OF RIGHTS IN THE NOVEL/BOOK FOR PRODUCTION OF A FEATURE FILM

The said Novel of the Assignor is released all over the World. A soft copy as well as a hard copy of the said Novel duly signed by the Assignor is handed over to the Assignee.
- (b) The Assignor desires to sell, transfer and assign copyrights of the said Novel and the Assignee has approached the Assignor to buy and purchase the said copyrights of the said

Novel. Hence, the Assignor is assigning the said copyrights of the said Novel to the Assignee for the purposes as appearing hereinafter. Any reference to a feature film hereinafter shall expressly include motion pictures.

**NOW THIS INDENTURE WITNESSETH AND IT IS HEREBY AGREED AND RECORDED BY AND BETWEEN THE PARTIES HERETO AS HEREUNDER:**

**1. RECITALS**

The aforesaid recitals contained herein shall form an integral part of the present Deed.

**2. RIGHTS ASSIGNED TO THE ASSIGNEE**

The Assignor confirms that the rights assigned to the Assignee in respect of the said Novel *inter alia* includes:

- (a) Exclusive, complete and entire rights of the feature film/s including common law and statutory copyrights of the same throughout the world, together with all copyright benefits of the said Novel, title and theme thereof and the exclusive right to show and project the same.
- (b) The exclusive right including all incidental rights to make feature films and versions thereof and to produce and reproduce one or more feature films.
- (c) The exclusive right to record and reproduce the language, speech, songs, music, dancing, choreography and other sounds in the feature film based upon the said Novel.
